## RESOLUTION #24-46

A RESOLUTION BY THE MAYOR AND COUNCIL OF THE CITY OF DUBLIN TO AWARD A BID TO SIKES BROTHERS, INC. FOR THE 2024 RESURFACING PROJECT; TO AUTHORIZE THE CITY MANAGER TO APPROVE CHANGE ORDERS; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER LAWFUL PURPOSES.

**WHEREAS**, the City has solicited bids for the 2024 Street Resurfacing project (the "Project"); and

WHEREAS, Sikes Brothers, Inc. has provided the low bid in the amount of \$246,897.00; and

WHEREAS, the City has been awarded \$268,237.43 in Local Maintenance and Improvement Grant (LMIG) funds and is required to match said funding with 10% contribution from the City (\$26,823.74), additional LMIG funding totaling \$332,199.17, and has up to \$205,136 in TIA Discretionary funds to supplement the Project; and

WHEREAS, the Mayor and Council desire to empower the City Manager to authorize and approve change orders up to and including the total amount of resurfacing funding including the City's 10% match, \$832,396.34, in an effort to streamline the resurfacing project and the Mayor is authorized and directed to execute and deliver the same upon said approval; and

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL** that Sikes Brothers, Inc. is hereby awarded the Bid for the City's 2024 Street Resurfacing Project.

**BE IT FURTHER RESOLVED** that the City Manager is authorized to approve future change orders with Sikes Brothers, Inc. within a total budgeted amount of \$832,396.34 and the Mayor is authorized and directed to execute and deliver any addendums or contract amendments to effect the same on behalf of the City; Any change orders in excess of the authorized amount herein may be approved only by further action of the Mayor and Council.

**BE IT FURTHER RESOLVED** that all actions of the City, its officers, and staff in connection with the execution, delivery, and performance of the Project and the purposes of this Resolution are hereby approved, ratified, and confirmed. Upon recommendation of the City Manager, the Mayor is further authorized to execute any other document in furtherance of the purposes of this Resolution.

**BE IT FURTHER RESOLVED** that this Resolution shall have immediate effect upon its adoption.
