FIRST READING OF ORDINANCE #24-01 TO ANNEX 331 ACRES OF LAND LOCATED ON HIGHWAY 257.

City Manager Powell read ordinance #24-01 to annex 331 acres, more or less, of land located at Parcel 100 067, 1 and 2 as M2 zone. The second reading and public hearing will be at our February 1st council meeting. DISCUSSION AND ACTION ON A CONTRACT TO THOMAS & HUTTON ENGINEERING FOR DESIGN SERVICES FOR THE CHURCH STREET/RICE AVENUE SEWER REPAIR PROJECT.

City Manager Powell explained that in order to address the sewer issue on North Church Street, I've requested Thomas and Hutton to submit to us a proposal for their services to engineer the replacement and upgrade of the portion of the sewer line that staff believes to be the problem. In discussing the project with them, there is a general concern that this project wouldn't be substantial enough to incentivize a contractor to bid on Therefore, staff propose to add the Rice Avenue project, it. another maintenance issue, to this in order to make it large enough to attract bidders. The proposal from T&H includes the general engineering consultation services, surveys, easement plats, design, permitting, bidding, construction administration, and they will bill for any additional services needed on a time and expense-based budget. The total for engineering services on both projects is \$97,200, plus the time and expense that is exceeded on those items as quoted in the proposal. Staff recommended using SPLOST 2018 funds for the project. Councilman Mascaro made a motion to approve the contract and seconded by Councilman Smith. The motion carried 7/0 to approve.

DISCUSSION AND ACTION ON TRAFFIC CALMING FOR EARLWOOD DRIVE.

Staff evaluated and considered the closure of both ends of Earlwood Drive and received feedback from the residents about each. City Manager Powell explained that if council votes to close the Veteran's Blvd side of Earlwood, staff will work with the neighborhood to see if they want to participate in a functioning gate. If they do not, staff will recommend one that will work for the city's purposes and provide access to emergency responders; sanitation; school busses, etc. Additionally, staff will need to make improvements to the Walke Dairy entrance/exit to accommodate the larger vehicles going in and out from there. Councilman Griggs made a motion to close Earlwood at the Veterans Blvd entrance and seconded by Councilwoman Kolbie. The motion carried 7/0 to close.

DISCUSSION AND ACTION ON BOARD APPOINTMENTS

Mayor Kight recommended to council the reappointment of Laura Irwin to the Library Board. Councilman Jones made a motion to reappoint and seconded by Councilwoman Kolbie. The motion carried 7/0 to approve.
